

DAYCARE TERMS AND CONDITIONS:

Southern Pines Pet Lodge & Training Academy recommends all dogs be spayed or neutered by 13 months of age however it is not required for daycare or boarding.

To ensure the health and safety of your dog and all other guests, we require that all of our clients agree and comply with the following terms and conditions:

1. I specifically represent to Southern Pines Pet Lodge LLC (Southern Pines) that I am the legal owner of my dog. In addition, my dog is healthy, my dog meets Southern Pines' vaccination standards, my dog has not harmed or shown aggression or threatening behavior towards any person(s) or other dog(s) and has not been exposed to any known communicable disease within the 30 period immediately prior to admission to day care. I further represent that each time my dog is brought to Southern Pines, I will be recertifying that my dog is in good health and has not had any communicable illness of any kind for 30 days prior to admission. I further agree to inform Southern Pines of any changes in my dog's condition and/or behavior prior to any day care visit.
2. I am aware of the risk involved if my dog is not Spayed or Neutered. Furthermore, I have been made aware by Southern Pines that should my Female dog go into heat during her Daycare stay that she will need to be separated from the Daycare group for her safety OR should my Male dog become obsessive with humping, or licking other dogs that he will need to be separated from the Daycare group.
3. I understand Daycare is offered between 7:30 A.M. – 6:00 P.M. Dogs not picked up by closing time (6:00 P.M.) will be charged an additional full day of boarding (Priced according to my dogs weight) and an emergency boarding charge of \$30 to be paid upon pick up.
4. I understand I must provide proof that my dog has the required vaccines of Rabies, Bordetella and Distemper/Parvo and that Southern Pines highly recommends my dog have the Canine Influenza vaccine. I acknowledge that it is my responsibility to ensure that my dog continues to be fully vaccinated and that Southern Pines reserves the right to deny services if my dog is not up-to-date on its vaccinations.
5. I understand that Southern Pines highly recommends my dog have flea and tick protection. I understand that my dog will be inspected for fleas when entering Southern Pines, and will be refused entrance OR charged for a Flea treatment if fleas are found. I further acknowledge that Southern Pines shall not be held responsible if my dog contracts fleas while at Southern Pines because proper flea protection is my responsibility.
6. I understand that the leash-free Daycare environment at Southern Pines provides dogs the opportunity to play in close physical contact, including with their teeth and paws. I acknowledge that no amount of supervision or personalized care by Southern Pines, its agents or employees, can prevent the possibility of injury or illness to my dog.
7. I accept the risks involved and agree that I am solely responsible for any damages that result from injuries caused by my dog while at Southern Pines. I agree to indemnify and hold harmless Southern Pines from any and all claims, liabilities, costs and expenses, including court costs and attorney fees, arising out of any harm or injury caused by my dog to other dogs or persons.
8. I authorize Southern Pines to do whatever is deemed necessary for the safety, health and well-being of my dog and I agree to assume full financial responsibility for any and all medical

expenses incurred. I expressively wave and relinquish any and all claims against Southern Pines, its employees, agents, and representatives for any injury, illness, or harm to my dog. Under no circumstances will Southern Pines be liable for consequential damages or damages beyond the replacement value of my dog.

9. I understand Southern Pines reserves the right to refuse admittance to any dog that displays signs of untreated or potentially contagious conditions, demonstrates aggressive behavior, or who fails the standard health and temperament policies set forth by Southern Pines. I further understand and agree that any problems that develop with my dog will be treated as deemed appropriate by the staff of Southern Pines, in their sole discretion should I be un-reachable.

10. I understand that when a pet comes in for boarding, daycare, or training there are some things to be aware of upon taking my pet home. During their stay they will have a lot of activity and mental stimulation such as but not limited to playing ball in our yards, focusing on learning certain commands during training, or wrestling with our daycare group. It is common for pets to be tired for 24 to 48hrs after returning home from their stay. If I become concerned, I should contact my vet immediately.
